### ***ENVIRONMENTAL ASSESSMENT FOR THE PORT HOPE LONG-TERM LOW-LEVEL RADIOACTIVE WASTE MANAGEMENT PROJECT***

Natural Resources Canada, the Canadian Nuclear Safety Commission and Fisheries and Oceans Canada – the federal responsible authorities – invite your comments on the draft screening report for the proposed Port Hope Long-Term Low-Level Radioactive Waste Management Project. The environmental assessment of the project is being conducted pursuant to the requirements of the *Canadian Environmental Assessment Act*.

The public comment period will end on September 29, 2006. All comments are considered public and will be placed on the public registry.

Open Houses will be held to provide information and solicit comments about the draft screening report. They will take place on Monday, September 11, 2006 from 2:30 to 5:30 pm and again, from 7:00 to 9:30 pm at the Port Hope Lions Recreation Centre, 29 Thomas Street, in Port Hope. Presentations by the responsible authorities on the draft screening report will be made at 3:00 and at 7:30 pm.
